NETWORK ENROLLMENT AGREEMENT

Nontank Vessel

PART I

- A. Alaska Maritime Prevention & Response Network (Network) is a nonprofit Alaska business entity formed for the purpose of providing vessel owners with the opportunity for regulatory compliance through Alternative Planning Criteria for Nontank Vessels developed by the Network and approved by the United States Coast Guard (Network NTV APC).
- B. The NTV APC is applicable to nontank vessels which transit or trade in Western Alaska and/or Prince William Sound USCG Captain of the Port Zones. Enrollment of a nontank vessel in the Network NTV APC will allow the vessel owner/operator and the vessel (collectively, Planholder) to comply with the Code of Regulations, Title 33, Chapter 155, Subpart J, Nontank Vessel Response Plans.
- C. Planholder wishes to utilize the Network NTV APC for regulatory compliance purposes for all of Planholders nontank vessels and to remit applicable enrollment fees for each vessel when it transits or trades in the area covered by the Network NTV APC.

AGREEMENT

The Network and the Planholder identified herein agree that the Planholder will be enrolled in and allowed to utilize the Network NTV APC for regulatory compliance purposes subject to completion and submission of the information required below (Part I) and subject to the further terms and conditions set forth in (Part II), Terms and Conditions of the Network Enrollment Agreement.

Enrollment of the Planholder and Planholder's nontank vessels in the Network NTV APC shall occur upon (a) the completion and submission of Part I, including Schedule A, of this agreement and (b) issuance thereafter of a fully executed Fleet Enrollment Certificate of Participation.

The Planholder identified below agrees that Part II, Terms and Conditions of the Network Enrollment Agreement, is fully incorporated herein and further accepts the authorized signature on Planholder's Certificate of Participation as Network's endorsement and acceptance of this Enrollment Agreement.
